1. Promoter

The promoter is Mum's Guide To Limited of 17 Park Avenue South, Harpenden, Hertfordshire AL5 2DZ.

2. Eligibility

This Competition is open to residents of the UK who are 18 years or over, except employees of Mum's Guide To Limited and their families, and anyone else professionally associated with the Competition.

Only one entry per person is permitted and entries that are automatically generated by computer will be disqualified.

3. How to enter
