1. Promoter

The promoter is Mum's Guide To Limited ("MGT") of 17 Park Avenue South, Harpenden, Hertfordshire AL5 2DZ.

2. Prize

A family ticket for 2 adults and up to 3 children to one day of the Hertfordshire Steam & Country Show, taking place at Standalone Farm in Letchworth on Saturday May 30th and Sunday May 31st 2026. The ticket is for entry on one day only- chosen day is at winner's discretion. Cannot be used in conjunction with any other promotions.

The winner will be contacted by MGT to arrange claiming their prize. Booking will be arranged directly between the winner and the event organisers of the Hertfordshire Steam & Country Show, following MGT providing the winner's details to them.

The prize is subject to availability, non-transferable and there is no cash alternative. MGT reserves the right to replace any or all of the prizes with an alternative prize or prizes if circumstances beyond MGT's control make it necessary to do so.

3. Eligibility

This Competition is open to residents of the UK who are 18 years or over, except employees of MGT and their families, and anyone else professionally associated with the Competition.

Only one entry per person is permitted and entries that are automatically generated by computer will be disqualified.

4. How to enter

Entry to the competition starts on Monday 18th May 2026 and the closing date is 23:59 BST on Sunday May 24th 2026 ("**Closing Date**").

No purchase is required.

Late, illegible, incomplete or inaccurate entries will not be accepted. No responsibility can be accepted for lost entries and proof of transmission will not be accepted as proof of receipt.

Neither Mum's Guide To nor any other 3rd parties can be held responsible for any failure of systems to register or record competition entries via any valid entry mechanism for this competition.

The winner will be drawn at random from all entries received by the closing date. The decision of the judges is final and no correspondence will be entered into.

5. Notification

Should that alternative winner not be immediately contactable by telephone, MGT reserve the right to keep re-drawing a winner until a winner has been found who is contactable by telephone immediately.
